

## Qualified Customer

To participate in the program you must be a current customer of Southern California Gas Company (SoCalGas®) or San Diego Gas & Electric® (SDG&E®).

The only applicable market segments allowed to participate are within the foodservice industry. Specifically, participants are limited to:

- ▶ commercial, family-style or fine-dining-style restaurants;
- ▶ not-for-profit food kitchens;

- ▶ government commissaries (such as those on military bases);
- ▶ college/university commissaries and kitchens;

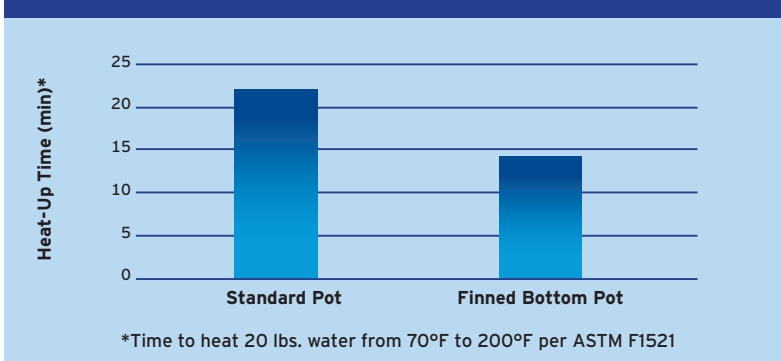
