#### SoCalGas Response:

- a. Provide a detailed explanation of the recorded dollar amount increased from 2008 to 2009.
  - i. There is a net increase in the O&M Shared Services for the Director Environmental Services incurred costs of \$247 due primarily to an increase in labor dollars because of vacancy timing and the shift of the E&S training instructional designer employee to the Environmental Services department. There was also a \$48k increase in non-labor for contract work to support environmental surveys and natural resources biological monitoring.
- b. Provide a detailed explanation and supportive documentation justifying your forecasted dollar amount increase for 2012.
  - i. A detailed explanation and supportive documentation that justifies SoCalGas' forecasted dollar amount increase for 2012 are contained in SCG-15-WP, Witness: L. Gomez pages 10 through 93 of 93 for the O&M shared services.

# SoCalGas Response:

- a. Provide a detailed explanation of the recorded dollar amount increased from 2008 to 2009.
  - i. The amount billed-in from SDG&E to SoCalGas in 2008 increased \$25k from 2008 to 2009. The reason for the increase is because SDG&E staff provided incrementally more support of SoCalGas projects. Shared services percentages were adjusted to align with changes in SoCalGas-related work activities conducted by SDG&E employees resulting in the increase in billed-in dollars.

This "billed-in" cost center collects the dollars incurred in SDGE shared service cost centers.

- b. Provide a detailed explanation & supportive documentation justifying your forecasted dollar amount increased for 2012.
  - i. There was a dollar amount increase in the O&M Shared USS Billed-in from SDG&E for a net increase of \$667k. This net increase is due primarily to upward pressures in the shared service program work activities for two cost centers (2100-3282 and 2100-3035). The specific work programs/activities for the increases include mitigation strategy development, environmental and safety training design, vendor audit program and regulatory tracking activities.

Environmental Services developed their estimate of 2012 costs utilizing a zero-based analysis using 2009 as the base year and detailing incremental upward and downward pressures for 2010, 2011 and 2012. The new environmental laws are identified as incremental upward pressures by year. Since the incremental change for the new environmental law was estimated based on its effective date or a proposed implementation date, the cost per year applies only to the years in the GRC period from 2010 to 2012 as appropriate and do not apply to the historic years.
