This letter is to inform you that your property, known as Assessor Parcel Number 063-0-200-190 located in Ventura County, CA has been identified in a feasibility study that Southern California Gas Company (SoCalGas) recently completed regarding a planned modernization project at SoCalGas' Ventura Compressor Station located at 1555 N. Olive Street in the City of Ventura.

SoCalGas maintains and operates compressor stations that are strategically located along its pipeline system to keep the natural gas moving along the pipeline. The Ventura Compressor Station is the northern most compressor station on the SoCalGas coastal transmission system. The facility currently supplies natural gas for heat, hot water, and other uses to over a quarter of a million customers in Ventura and the Central Coast, including residential, business, industrial, and agricultural customers.

The existing station compressor equipment was installed in the 1980s and is approaching the end of its useful life. The equipment needs to be modernized to meet the current and future needs of California's energy infrastructure. SoCalGas intends to modernize the facility by replacing the three existing gas compressors at the Ventura Compressor Station with four new gas compressors. In August 2021, the California Public Utilities Commission (CPUC) requested that SoCalGas conduct a feasibility study for its planned modernization project. The CPUC asked for SoCalGas to analyze alternative site locations and equipment configurations to the planned project. In response to that request, SoCalGas assessed potential alternative locations for the compressor station, some of which were identified by the community and some of which were identified by SoCalGas. Your property was one of the alternative locations identified in SoCalGas's feasibility study.

As such, we wanted to inform you that the feasibility study will be made available and the findings of the study will be presented at public forum meetings held on March 29th, 31st and April 2nd.
